## Sept. 10 to 19 — EXISTING plan open enrollment

Open enrollment for EXISTING WEA Select health care plans, including for new employees and those who need to change plans or dependents. These changes will only affect insurance coverage in November and December because existing plans end Dec. 31, after which the SEBB will be in place. You do not need to change plans at this time unless you want to. Your deductibles will not reset if you remain on your WEA Select plan through the end of the year. ## Oct. 1 to Nov. 15 — SEBB open enrollment

This applies to ALL K-12 school employees, including new employees and those who made changes during the open enrollment period for existing plans (see previous bullet).

## Jan. 1, 2020 — SEBB benefits take effect

The new SEBB health care system begins. Existing insurance plans end.
