### 2020 –2021 SEA National Board Candidate Support Cohort Program

SEA provides facilitated support for candidates going through the National Board for Professional Teaching Standards certification process. Candidate support is optional for teachers completing their National Boards; however, teacher candidates who are part of a support program show a significantly higher passing rate.

As part of a cohort, candidates receive support, instruction, and feedback from their trained facilitators who are SEA colleagues. Examples include: “unpacking” the National Board component prompts, finding evidence of National Board standards, and ensuring alignment. Clock hours will be available.

#### What courses are offered & when do they meet?

<b>Component One: Content Knowledge</b>	Discussion of certification area standards and analysis of prompt descriptors. Self-assessment of knowledge in content area. Learn about Constructed Response Items and Selected Response Items as well as assessment ethics, procedures, appointments, and general overview of C1.	(12:30 – 3:00pm) Oct. 17 Jan. 9 Feb. 6
<b>Component Two: Differentiation in Instruction</b>	The Five Core Propositions and the Architecture of Accomplished Teaching will be woven throughout the analysis and study of certification area standards and Component Two instructions. Meetings include time for Q&A, conferencing, drafting, and peer review.	(9:00 – 11:30am) Oct. 3 Dec. 5 Jan. 23 Feb. 27 April 3
<b>Component Three: Teaching Practice &amp; Learning Environment</b>	The Five Core Propositions and the Architecture of Accomplished Teaching will be woven throughout the analysis and study of certification area standards and Components Three instructions. Meetings include time for Q&A, conferencing, drafting, peer review, plus video review and analysis.	(9:00 – 11:30am) Oct. 17 Nov. 14 Jan. 9 Feb. 6 March 20
<b>Component Four: Effective and Reflective Practitioner</b>	This component requires teacher candidates to gather information from a variety of sources about a group of students; use assessments to effectively plan for and positively impact their students’ learning; and provide evidence of their collaboration with families, the community, and colleagues and of their contributions to learning communities to advance students’ learning and growth. Meetings will include time for Q &A, conferencing, drafting, peer review, and reflection.	(12:30 – 3:00pm) Oct. 3 Dec. 5 Jan. 23 Feb. 27 April 3

**What time are the meetings?** Saturday meeting times vary per Component.

**Where are the meetings held?** All meetings will be held virtually. Details to follow. We recommend that you sign up for a Google account in order to more easily access materials on a shared Google Drive.

**What is the cost?** Candidates pay a registration fee of \$75 to finalize and confirm their place in the cohort. Candidates also pay support fees based on Components selected. Note that WEA/SEA member prices are lower. To become a SEA member you can join electronically via this link:

**\*Foundations Course** is offered for those who did not attend the WEA Jump Start Program and is a prerequisite for Components One, Two, Three, Four, & for those receiving the OSPI conditional loan\*\*. If you attended the WEA Jump Start Program in August, you do not need to take the Foundations Course.

#### **Reimbursement Policy:**

Full payment (Component Courses and Registration Fee) is due by Nov. 7 unless alternative arrangements are made with SEA. Failure to pay or make arrangements with SEA may result in being dropped from the Program.

A 50% refund is available to candidates who formally withdraw by contacting SEA prior to December 31, 2020. No refunds will be available after December 31, 2020. Any candidate who withdraws or ends participation in the SEA NB Candidate Support Program at any point during the year and chooses to participate in the program at a later date will need to resubmit full payment for the subsequent year's program.

**If a candidate signs up for the National Board process between May 1<sup>st</sup> and July 31<sup>st</sup> 2020, at a minimum, they will have access to the following types of support:**

- OSPI Conditional Loan (must apply – first come, first served)
- WEA Jump Start\* (offered by Washington Education Association)
- SEA Foundations (or attendance at WEA Jump Start\*)
- SEA Cohort Support for C1, C2, C3, C4 (offered by Seattle Education Association)
- WEA Homestretch\* (offered by Washington Education Association)

**If a candidate signs up for the National Board process between August 1<sup>st</sup> and November 30<sup>th</sup> 2020, at a minimum, they will have access to the following types of support:**

- OSPI Conditional Loan (must apply – first come, first served)
- SEA Foundations (or attendance at WEA Jump Start\*)
- SEA Cohort Support for C1, C2, C3, C4 (offered by Seattle Education Association)
- WEA Homestretch\* (offered by Washington Education Association)

**If a candidate signs up for the National Board process between December 1<sup>st</sup> 2020 and January 1<sup>st</sup>, 2021, at a minimum, they will have access to the following types of support:**

- SEA C1 and SEA Foundations only
- OSPI C1 and Foundations online (available to those in rural/remote areas and offered by OSPI)
- WEA Homestretch\* (offered by Washington Education Association)

**If a candidate signs up for the National Board process between January 1<sup>st</sup> 2021 and the registration deadline**, at a minimum, they will have access to the following types of support:

- WEA Homestretch\* (offered by Washington Education Association)
