# **BACKGROUND**

Last year the WEA passed NBI 31, directing the WEA to assist locals and councils in enrolling and representing substitute educators. NBI-31, passed at RA 2016, directed WEA to assist locals and councils in enrolling and representing substitute educators, including a meeting during this RA.
